

2009 DC Dragon Boat Festival Youth Team Training Agreement

I/We the undersigned agree to take responsibility for the control and management of the youth(s) listed below for their training with the National Capital Area Women's Paddling Association (NCAWPA) or DC Dragon Boat Club (DCDBC) and for their involvement in the DC Dragon Boat Festival.

By signing this document, I/we agree to be present at all practices hosted by NCAWPA or DCDBC and responsible for the following actions in regard to the youth(s) listed. **At least two (2) Responsible Adults, in addition to the Team Captain, will always be present to monitor and manage:**

- Direction and conduct from parking or gathering areas to the dock prior to / at the beginning of each practice.
- Safe conduct on the docks prior to boarding the boats and while unloading the boats according to the safety procedures outlined by NCAWPA or DCDBC training staff.
- Ensure that all youth paddlers are properly wearing appropriate Personal Floatation Devices (PFDs) whenever in the dock area or in any NCAWPA or DCDBC boat.
- Direction and conduct from dockside to departure with designated adult(s) post disembarking from the boat. All designated adult(s)/guardian(s) must be listed below.

Youth(s) not indicated on this Agreement MAY NOT participate in any training activities.

I/We understand and recognize that there is always an inherent risk of bodily injury and harm associated with paddling, swimming and other outdoor activities. No warranties or representations of any kind have been made by NCAWPA or DCDBC, its members, agents, officers, directors, trustees, successors or assigns regarding the activities at or around the Anacostia Community Boathouse or Gangplank Marina.

Signing this Agreement signifies that I/we and our child hereby personally assume any and all risks in connection with my/our child's participation in and attendance at NCAWPA or DCDBC and/or DC Dragon Boat Festival Training Activities. We waive and release NCAWPA or DCDBC, its officers, trustees, employees and volunteers, as well as any of its sponsors and/or affiliates and any associated individuals or entities from any and all claims related to my/our child's attendance at NCAWPA or DCDBC training programs. I/We further agree to indemnify and hold harmless NCAWPA or DCDBC, its officers, trustees, employees and volunteers, against and from any and all claims for personal injury, damages, costs and/or other expenses, including attorneys fees, arising from or in any way connected with our child's participation in or attendance at DC Dragon Boat Festival Training hosted by NCAWPA or DCDBC.
